**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

**1.) Entry:** To enter, access the [www.sarasotafl.org/promo/scvngr](http://www.sarasotafl.org/promo/scvngr) website (the "Website") or text "intersections" to SCVNGR (728647) to begin playing game. You must be in downtown Sarasota, FL USA to participate in the SCVNGR hunt and complete the entire SCVNGR hunt which consists of visiting 12 spots (Locations where Intersections Statues can be found) all located within downtown Sarasota, FL.

Contest begins at 5:00 p.m. ET on January 20, 2011 and ends at 11:59 a.m. ET May 1, 2011. Once submitted, entries become the exclusive property of Sponsor and will not be returned.
